

From the President

The College is a special organization that combines learning and socializing in unique ways. Our highlight is the Annual Meeting, and this year's meeting was wonderful. Hawaii made for a beautiful backdrop for our week together. When we come together each year, we anticipate an outstanding program, which enables us to receive cutting-edge information from outstanding speakers, both Members and Non-Members, and this year was no exception. Our Program Chair, Manny Tancer, Past President Bob Golden, and the Program Committee put together an a well-organized and well-thought out program, bringing us insights about pressing issues that are pertinent to psychiatry, including our nation's growing epidemic of violence; the future of health care delivery, with an emphasis on the emergence of integrated care; and physician wellness across the full continuum from medical student to senior clinician. There were important updates in areas ranging from Alzheimer's Disease to HIV/AIDS, as well as courses that focused on technology, refractory mood and anxiety disorders, and the clinical implications of the evolving access to medical and recreational marijuana use across the country. It was an enjoyable, topical, and engaging program; my congratulations to Manny and the Program Committee on a job well done. And we had so much fun.

The College also has a major leadership role for psychiatric education nationally. PRITE and CHILD PRITE remain the gold standard for assessing psychiatry residents. Nearly all residency programs in the United States and about half in Canada utilize the exams to



evaluate their residents and the effectiveness of their curricula. In addition to being a staple of graduate medical training in psychiatry, the exams serve as an important source of prestige and revenue for The College.

The Psychiatrists In-Practice Exam (PIPE) continues to play a significant role in the maintenance of certification (MOC) process. PIPE sales have continued to go through the roof, with 1,104 sold last year (the first time the 1,000-mark has been broken), up nearly 32 percent from 2017, and almost 87 percent from 2016. As a reminder, College Members receive a discount when purchasing PIPE (\$195).

Membership in The College continues to be strong. At the 2019 Annual Meeting in Hawaii, we welcomed 33 new Members into The College and elevated five current Members to Fellowship status. Thanks to the diligence of the Committee on Membership, our newest recruits include some of the leading lights in research, academic, and clinical psychiatry. Those New Members join an impressive and dedicated group. We're fortunate to have a steady supply of willing, capable volunteers

to staff committees, develop Annual Meeting programs, select awardees, write PIPE and PRITE questions, and ensure the smooth operation of The College. As President, I assure you this is something we truly appreciate and never take for granted.

College financial reserves remain strong and the organization has continued to operate in the black, thanks to the Board of Directors and the Finance Committee, working with Mediqus Asset Advisors. In fact, The College's portfolio has outperformed several economic indexes and continues to appreciate.

Looking ahead to the 2020 Annual Meeting in Fort Lauderdale, I thought I'd first make a brief foray into the past: the last time The College met in Fort Lauderdale was 10 years ago. Dwight Evans was President, Archbishop Desmond Tutu gave a special talk to Members, and the theme of the meeting was Translating Scientific Advances into Psychiatric Practices. Prior to that, The College met in Fort Lauderdale in 1991.

For our 2020 Annual Meeting in February, Scott Aaronson, his Program Committee, and I have chosen the theme of "A 20/20 Vision of the Future." This program will include a forum on Wednesday morning that will tackle "The Changing Paradigm of Psychopharmacology: Psychedelics, MDMA and NMDA Antagonists," with plenaries and a panel featuring preeminent experts in this area. There will also be presentations by specialists in the fields of bipolar disorder, psychoimmunology, and trauma; plus sessions that will take a deep dive into the areas of violence and aggression, health care policy, the opioid crisis, and more.

The Annual Meeting will also include a new component: two "Breakfast with the Experts" sessions on Thursday and Friday mornings prior to the general sessions that will feature roundtables presided over by experts in a variety of topic areas. This will allow attendees to tap into the expertise of seasoned College Members and exchange information and ideas in a more informal setting.

You'll find a preliminary version of the Annual Meeting program further on in this newsletter. Hopefully the content will fit your needs; I look forward to feedback after the meeting.

It is an honor and a privilege to serve as President of an organization that has been an important part of my life since I became a member 40 years ago in 1979. If there is anything I can do to enhance your College experience during my term, please let me know. I look forward to hearing from you and seeing you in Fort Lauderdale in 2020.

From the Executive Director

Ask any Chicagoan a question about a building in the city and you're likely to elicit a strong opinion. We all fancy ourselves architecture buffs, and with good cause: After the Chicago fire of 1871, architects and builders poured into the city, resulting in a concentration of architecturally significant buildings in the Loop. The post-fire building boom also saw the invention of the modern skyscraper, with the weight of buildings supported by interior steel frames rather than load-bearing walls, and the floors served by Otis's new invention, the elevator. The innovations continued in the 20th and 21st centuries, with projects by such noted architects as Ludwig Mies van der Rohe, Philip Johnson, Renzo Piano, Frank Gehry, Helmut Jahn, Jeanne Gang, and many more.



Why am I focusing my column on architecture, you might ask? For two reasons. First, The College office is in a notable building. 111 East Wacker Drive is part of a mixed-use complex of skyscrapers known as Illinois Center, which was designed by Mies van der Rohe in the 1970s. Clad in bronze, the building is in Mies's International Style—a spartan style of architecture that he deemed suitable for use anywhere in the world. The building presents quite a contrast to our former home in an ornate century-old building. After that experience, we appreciate the clean lines of our new office and the natural light afforded by the large windows.

Not coincidentally, our building also houses the Chicago Architecture Center (CAC), which offers walking, boat and bus tours throughout the city. For our annual summer outing this year, the staff has chosen an architectural river tour. Weather permitting, this week we'll cross the street, take the stairs down to the Riverwalk and board a CAC boat for a tour of the south, north and main branches of the Chicago River. The river offers a great vantage point from which to enjoy the architectural richness of the city. I've taken the tour half a dozen times and still learn something new each time I go.

So next time you're in Chicago, ask a Chicagoan to name his/her favorite building, take the architectural boat tour, and stop by the office. We'd love to see you!

The American College Of Psychiatrists Selects New Board Members, Officers

The American College of Psychiatrists elected new Members to its Board of Regents and selected Board Officers at its Annual Meeting in Honolulu, Hawaii, on February 23, 2019. Members of the Board of Regents provide strategic leadership and oversight for the programs and future direction of The College.



Steven S. Sharfstein, M.D.: Steven S. Sharfstein was named President of The College. Dr. Sharfstein is President Emeritus of the Sheppard Pratt Health System, where he served for 30 years. He is currently Clinical Professor of Psychiatry at the University of Maryland. Dr. Sharfstein spent 13 years in leadership roles at

the National Institute of Mental Health and at APA where he served as President. He attended Dartmouth College and earned his medical degree at Albert Einstein College of Medicine. He completed his residency in psychiatry at the Massachusetts Mental Health Center in Boston, and subsequently received an M.P.A. from the John F. Kennedy School of Government at Harvard.



Laura Roberts, M.D., M.A.:

Laura Roberts assumed the role of President-Elect of The College. Dr. Roberts serves as Chairman and the Katharine Dexter McCormick and Stanley McCormick Memorial Professor in the Department of Psychiatry and Behavioral Sciences at the Stanford University School of

Medicine. She serves as the Editor-in-Chief for American Psychiatric Association Publishing, Books Division. She will soon be ending her tenure as Editor-in-Chief for the journal *Academic Psychiatry*, a role she has filled since 2002. Having received her bachelor of arts in history and master of arts in the conceptual foundations of science from the University of Chicago, she then completed her medical degree and a fellowship in clinical medical ethics at the University of Chicago Pritzker School of Medicine. Dr. Roberts received her residency training in psychiatry at University of New Mexico School of Medicine, where she then joined the faculty and established the University of New Mexico Institute for Ethics. Prior to her move to Stanford, she served as the Chairman of Psychiatry and Behavioral Medicine at the Medical College of Wisconsin.



Larry R. Faulkner, M.D.: Larry R. Faulkner was selected as First Vice President of The College. Dr. Faulkner is President and CEO of the American Board of Psychiatry and Neurology. From 1994 to 2006, Dr. Faulkner served as Vice President for Medical Affairs and Dean of the School of Medicine at the University

of South Carolina. Among other awards, Dr. Faulkner has received the Distinguished Service in Psychiatry Award from the American College of Psychiatrists, the Seymour Pollack Award for Distinguished Contributions to the Teaching and Education Functions of Forensic Psychiatry, and a Special Presidential Commendation for the Promotion of Psychiatric Education and Lifelong Learning from the American Psychiatric Association. Dr. Faulkner received his undergraduate education at Whitman College and attended the University of Washington School of Medicine. He completed his residency at the University of Arkansas and a fellowship at National Institute of Mental Health.




Eugene V. Beresin, M.D.: Eugene V. Beresin was elected Second Vice President of The College. Dr. Beresin is Professor of Psychiatry at Harvard Medical School and Executive Director and Founder of the Clay Center for Young Healthy Minds at Massachusetts General Hospital. He is also Director of the Elizabeth

Thatcher Acampora Endowment, an outreach program to meet the needs of underserved youth and families in three community settings. Previously, he served as Director of the Child and Adolescent Psychiatry Residency Training Program at Massachusetts General Hospital and McLean Hospital. Dr. Beresin received his M.A. in philosophy and M.D. from the University of Pennsylvania. Subsequently, he completed an internship in pediatrics at Yale New Haven Hospital, his residency at Massachusetts General Hospital/Harvard Medical School, and a residency in child psychiatry at Boston Children's Hospital/Judge Baker Guidance Center/Harvard Medical School.



Donna M. Norris, M.D.: Donna M. Norris has joined The College's Board of Regents. Dr. Norris is in the clinical psychiatric practice of child, adolescent, adult, and forensic psychiatry in Wellesley, Massachusetts, a member of the Psychiatry & the Law Program, and staff Beth Israel Deaconess

Medical Center, and staff Children's Hospital Medical Center, Department of Psychiatry, Harvard Medical School. Previously, Dr. Norris was the first African American and woman Speaker of the APA Assembly, APA Secretary-Treasurer, and president of the Massachusetts Psychiatric Society. Currently, she is a Board Director of the Coverys Medical Liability Insurance Company. Dr. Norris obtained a B.A. at Fisk University and her medical education at The Ohio State University. She trained in adult psychiatry at Boston University and in child psychiatry at the Judge Baker/Children's Hospital, Harvard Medical School.



Christopher R. Thomas, M.D.: Christopher R. Thomas has joined The College's Board of Regents. Dr. Thomas is the Robert L. Stubblefield Professor of Child Psychiatry in the Department of Psychiatry and Behavioral Sciences at the University of Texas Medical Branch at Galveston. He currently serves as

the Assistant Dean for Graduate Medical Education and the Director of the Child and Adolescent Psychiatry Residency Training Program. His undergraduate training was at Rice University, Houston, and he graduated from Baylor College of Medicine, Houston. His residency in both general and child psychiatry was at McLean Hospital, Harvard University, Boston.

Eligible for Emeritus Status?

If you are over 70 or fully retired, you are eligible for Emeritus status in The College. As an Emeritus Member or Emeritus Fellow, you are no longer obligated to attend one of every three Annual Meetings or pay Active Member dues of \$420 (although we do suggest making a voluntary dues contribution of \$75).

Although Emeritus Members and Fellows may vote on all matters coming before the membership and serve on committees, they are not eligible to hold elective office or serve as a committee chairperson.


