From the President

It has been a busy and productive fall at The College.

In October, The College Board of Regents met in Chicago. We were pleased to welcome two new Board Members to our ranks. Donna M. Norris, M.D., maintains a clinical practice in Wellesley, Massachusetts, focused on child, adolescent, adult, and forensic psychiatry. She is also on the staff of Beth Israel Deaconess Medical Center, the Children's Hospital Medical Center and Harvard Medical School. Christopher R. Thomas, M.D., is the Robert L. Stubblefield Professor of Child Psychiatry, Assistant Dean for Graduate Medical Education, and Program Director for Child and Adolescent Psychiatry in the Department of Psychiatry and Behavioral Sciences at the University of Texas Medical Branch at Galveston.

The Board of Regents also approved 34 new Members and seven new Fellows who will be inducted in Fort Lauderdale. Twelve new Laughlin Fellows, two new PRITE Fellows, and two new CHILD PRITE Fellows will also attend the Annual Meeting. In order to achieve greater institutional and geographic diversity in its pool of applicants, the Laughlin Fellowship Selection Committee recently adopted a policy limiting each sponsoring institution to one candidate. As a result, the current crop of Laughlin Fellows represents more diverse academic medical institutions from across the U.S. and

Canada. For more information about this talented group of residents and fellows, see pages 7-8.

Fall is also PRITE and CHILD PRITE season at The College. Nearly 300 programs purchased PRITE in 2019, with 7,700 resident examinees. In addition, 139 child programs administered CHILD PRITE to nearly 1,000 examinees. PIPE sales were brisk this fall, as well, with the to-date total topping 915.

Fall has also seen the finishing touches being put on the Annual Meeting. As the centerpiece of the meeting, the educational program put together by Scott Aaronson, M.D., and the Scientific Program Committee promises to be quite cutting-edge. As I mentioned in the fall issue of the newsletter, the theme of the meeting is, "A 20/20 Vision of the Future," and the topics on which this theme will focus include a Wednesday morning forum tackling "The Changing Paradigm of Psychopharmacology: Psychedelics, MDMA and NMDA Antagonists," with plenaries and a panel

featuring preeminent experts in this area. There will also be presentations by specialists in the fields of bipolar disorder, psychoimmunology, and trauma. While the lineup of plenary sessions and presenters on the program is strong, they are more than matched by the content of the courses and interest groups. The breakout topics include child and adolescent psychiatry, treatment of grief, trauma and resilience, and end of life care. A complete program schedule can be found on pages 9-12 of this newsletter.

The Annual Meeting will also include a new component: two “Breakfast with the Experts” sessions on Thursday and Friday mornings prior to the general sessions that will feature roundtables presided over by experts in a variety of topic areas. This will allow attendees to tap into the expertise of seasoned College Members and exchange information and ideas in a more informal setting. We will send out additional information about these sessions, including how to secure a seat at your desired table, in January.

As always, Saturday morning will feature a stellar lineup of awardees. They are: Bowis Awardee: Ilisse R. From the Executive Director

An important measure of the health of any professional association is its pipeline of new members joining the organization. By that metric, The College is healthy, indeed. On average, we induct 35 New Members each year, which more than compensates for the handful of Members who leave the organization. But numbers don't tell the whole story. What challenges do new and younger Members face that The College could better address? How could The College improve the New Member experience?

The Board recently created a task force—the Task Force on Younger Members—to explore these questions and make recommendations to the Board. The Task Force met in Hawaii and came up with a list of suggestions to improve the New Member experience, several of which will be implemented at the 2020 Annual Meeting in Fort Lauderdale.

For example, the Task Force felt it is sometimes difficult for New Members to know what to expect from their first annual meeting. In 2020 and moving forward, the Chair of the Membership Committee will send a letter to new inductees covering everything from dress code to details about the Membership Lunch. Several Task Force Members also said attending the first annual meeting can be difficult socially—you may not know many or any of the other attendees. As a result, The College will set aside several tables at the Wednesday night welcome dinner for New Members, allowing them to interact with other recent recruits. We've also scheduled an optional Everglades Tour to help Members who may be traveling alone experience surrounding attractions in a group setting.

Younger Members may also be attending the meeting with children in tow. The New Member Orientation Letter will make it clear that The College is very family friendly, and children of all ages are welcome at social events. We've also added the availability of childcare services to our request for proposals for future meeting venues and we'll publicize what services are available at meeting hotels. For example, in Fort Lauderdale, for those traveling with children ages 5-12, the Marriott offers a daily drop off program called Surf Club. The cost is \$25 for the first two hours and \$10 for each additional hour.

The Task Force Members also discussed why younger psychiatrists join The College. One clear answer was the opportunity to meet and interact with more established members of the specialty. As Steve mentioned in his column, we're going to feature informal discussion tables focused on a variety of topics during the Thursday and Friday breakfasts to facilitate these types of interactions.

Finally, the Task Force, led by Board Member Joan Anzia, realizes the best way to find out how to improve the experience of younger Members is to ask for their input. The Task Force will be sending out a short electronic survey to recently inducted College Members (those who joined in the past five years) asking why they joined The College and soliciting ways to enhance their membership experience. In the meantime, please feel free to share with me your thoughts on these topics, and I'll be sure to relay your comments and suggestions to the Task Force.

Whether you're a recent or longstanding Member of the organization, we're glad to have you as part of the extended College family, and we wish you and yours the happiest of holidays.

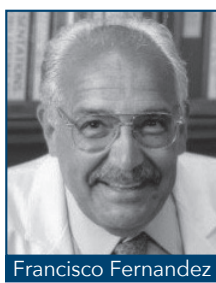

The American College of Psychiatrists has announced the recipients of its 2020 awards, which will be presented at The College's Annual Meeting in Fort Lauderdale on February 22, 2020. The awards recognize those mental health professionals responsible for advancing psychiatry through their service, research, clinical work, and educational activities.

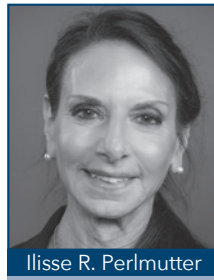


Francisco Fernandez, M.D., FACPsych, Receives the Distinguished Service Award

The Distinguished Service Award recognizes significant achievements and leadership in the field of psychiatry. A Past-President of The College, Dr. Frank Fernandez is a Professor in the Department of

Psychiatry and Neurology at the University of Texas Rio Grande Valley (UTRGV), where he also served as the Inaugural Dean of the School of Medicine. Prior to moving to Texas, Dr. Fernandez had been Professor and Chair of the Department of Psychiatry and Neurosciences and the Director of the Institute for Research in Psychiatry and Neurosciences at the University of South Florida College of Medicine in Tampa.

Dr. Fernandez has excelled in multiple spheres related to the practice of medicine and psychiatry, and is accomplished as well in the areas of administration, education, clinical work and scholarship. Dr. Fernandez focuses much of his time on advocating and improving the lives of individuals in underserved populations, such as those impacted by HIV/AIDS and poverty and ethnic/racial minorities. He is equally dedicated to supporting and facilitating the growth and development of other physicians at all stages of training, both by providing guidance to them and also by participating in and leading educational and mentoring programs at academic institutions and within national organizations.

Bowis Award Presented to Ilisse R. Perlmutter, M.D., M.S.W., FACPsych

Each year, The College presents the Bowis Award to a Member or Fellow in the organization who has played an important leadership role in The College. Dr. Ilisse R. Perlmutter was elected to The College as a

Member in 2001. Since that time, her contributions to The College have been substantial, including serving on the CME Committee and the Laughlin Fellowship Selection Committee, where she stood out for her strong dedication to mentoring the Laughlin Fellows. Dr. Perlmutter became Chair of the Membership Committee in 2015. She soon spearheaded a Committee effort to streamline and revamp the membership application process to more closely reflect the more varied forms of current psychiatric practice.

Dr. Perlmutter is Board certified in both Adult and Child Psychiatry. She has made substantial contributions not only to The College, but to the American Board of Psychiatry and Neurology (ABPN), for which she served as an examiner for many years, and the American Psychiatric Association.

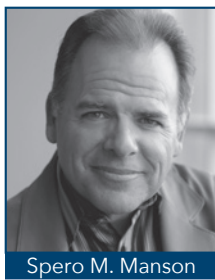

The Award for Creativity in Psychiatric Education was created to recognize noteworthy teaching innovations in the field of psychiatry. The College has selected Duke University Department of Psychiatry and Behavioral Sciences' program, "An Interprofessional Substance Use Disorders Course", to receive the 2020 award.

The overarching goal of the course is to allow students the opportunity to apply classroom learning in the clinical setting to shape their practice behaviors and impact patient outcomes. The course also provides students with opportunities to: improve their understanding of SUDs; assess, challenge, and reflect on their attitudes toward patients with SUDs; develop skills in patient communication; receive direct observation, assessment, and feedback on behavior change counseling; and learn with, about, and from other students and clinicians. This study's purpose was to evaluate the impact of an interprofessional SUDs course on students' educational outcomes (including attitudes, behaviors, and decisions about patients' treatment) and their attitudes toward inter-professionalism.

The course directly responds to the need for interprofessional substance use disorder education that can prepare students for collaborative care and for health professions education that can achieve educational outcomes affecting student behaviors and patient care.



Spero M. Manson, Ph.D., Named Honorary Fellow in The College

The American College of Psychiatrists awards Honorary Fellowships in The College to distinguished professionals who have made significant scientific and clinical contributions to the field of psychiatry. Dr. Spero M.

Manson, a Pembina Chippewa, is widely recognized as the nation's leading scholar in the area of American Indian and Alaska Native health with a particular focus on psychiatry and behavioral health. He is a Distinguished Professor of Public Health and Psychiatry, directs the Centers for American Indian and Alaska Native Health, occupies the Colorado Trust Chair in American Indian Health, and serves as Associate Dean of Research in the School of Public Health at the University of Colorado's Anschutz Medical Campus.

Dr. Manson's programs include ten national centers, representing more than \$63 million in sponsored research,

program development, training and collaboration with 250 Native communities, spanning rural, reservation, urban and village settings from Alaska to Florida, Maine to Hawaii. He has published 225 articles on the assessment, epidemiology, treatment and prevention of physical, alcohol, drug and mental health problems across the developmental life span of Native peoples. His work has received numerous honors and awards

In addition to Dr. Manson's scholarly contributions, he has mentored several generations of Native and non-Native scholars whose own careers and achievements have furthered Dr. Manson's life-long mission to improve the lives of Native peoples.



The College Names Celso Arango, M.D., Ph.D., Recipient of the Stanley Dean Research Award

The Stanley Dean Research Award honors an individual who has had a major impact on the diagnosis and treatment of schizophrenic disorders. Dr. Celso Arango is currently Chair of the Child and Adolescent Department

of Psychiatry at Hospital General Universitario Gregorio Marañón, Complutense University in Madrid, Spain, as well as Professor of Psychiatry at the Maryland Psychiatric Research Center of the University of Maryland in Baltimore, Adjunct Professor of Psychiatry at UCSF in San Francisco, Visiting Professor of Psychiatry at Kings College London, and Tenured Full Professor at Complutense University in Madrid.

Professor Arango's major research interests include the neurobiology of early onset and first-episode psychoses and neurodevelopmental psychopharmacology. He leads one of the few research groups in the world focusing on early onset psychosis with the largest cohort of pediatric first psychotic episode patients.

Professor Arango has transitioned to the field of early intervention and has created an innovative intervention program for first-episode patients and their families (PIENSA). He has also headed one of the world's foremost groups assessing side effects of antipsychotics in children and adolescents and has advanced the field of pediatric psychopharmacology, especially with respect to psychotic disorders.

Professor Arango holds a prominent leading position in European psychiatry. He is the Principal Investigator on more than 10 European Commission-funded grants such as EU-GEI, OPTiMiSE, Aggresotype, Matrics, ROAMER, EU-AIMS, and PSYSCAN, with funding of well over 200 million euros in total. Professor Arango is president of the European College of Neuropsychopharmacology and has written more than 405 peer-reviewed articles and eight books. He serves on the editorial board of 12 high impact journals, and has received more than 20 awards for his work.



Helen Lavretsky, M.D., Named Recipient of Award for Research in Geriatric Psychiatry

The Award for Research in Geriatric Psychiatry honors an individual who has made major contributions to the field of geropsychiatry. Dr. Helen Lavretsky is a Professor In-Residence in the Department of Psychiatry at

UCLA. Her current research studies include investigations of psychopharmacological treatment of geriatric depression, mild cognitive impairment and the use of Tai Chi and yoga for treatment and prevention of late-life mood and cognitive disorders.

Dr. Lavretsky's expertise as a practicing geriatric psychiatrist lies in the recognition and treatment of the mental and cognitive disorders of aging. As a clinical researcher, her expertise and contributions lie in her ability to understand neurobiology of the neuropsychiatric disorders of aging, and to develop novel treatments that encompass pharmacological, behavioral, and integrative medicine approaches.

She has served on the editorial boards of several scientific journals, and is a grant reviewer for the National Institute of Mental Health, the National Center for Complementary and Alternative Medicine, the Canadian Institutes of Health, the Alzheimer's Association, and the Alzheimer's Fund of California.

In recent years, Dr. Lavretsky has focused her career on the research mentoring of nearly 80 junior investigators ranging from high school students, undergraduates, graduates, and postgraduate students to junior faculty.



David J. Miklowitz, Ph.D. Selected as Recipient of Award for Research in Mood Disorders

The Award for Research in Mood Disorders is given to an individual who has advanced the understanding and treatment of depression and bipolar disorder. Dr. Miklowitz is a Distinguished Professor of Psychiatry

in the Division of Child and Adolescent Psychiatry at the UCLA Semel Institute, and a Visiting Professor in the Department of Psychiatry at Oxford University. His research focuses on family environmental factors and family interventions for children, adolescents and adults with bipolar disorder and youth at high risk for mood disorders or schizophrenia. His work has helped establish the effectiveness of psychosocial interventions as adjuncts to medication in the treatment of bipolar disorder.

Dr. Miklowitz has received numerous awards for his research and writings including the Mogens Schou Award for Research from the International Society for Bipolar Disorders and the Distinguished Scientist Award from the Society for the Science of Clinical Psychology. In addition, he has received multiple grants for his research from the National Institute of Mental Health and 10 private foundations. Dr. Miklowitz has published over 300 journal articles and chapters, and eight books. His book *Bipolar Disorder: A Family-Focused Treatment Approach*, won the Outstanding Research Publication Award from the American Association for Marital and Family Therapy, and his book *The Bipolar Disorder Survival Guide* is an international bestseller that has been translated into eight languages, with over 300,000 copies in print.

THE COLLEGE SELECTS 2020 LAUGHLIN FELLOWS:

Program Honors Top Psychiatry Residents, Future Leaders

The American College of Psychiatrists has announced the 2020 recipients of its prestigious Laughlin Fellowship.

Named after College founder, Henry P. Laughlin, M.D., the Fellowship program was launched in 1976 to recognize outstanding accomplishments by psychiatry residents in the United States and Canada. Each year, The College selects 12 residents deemed most likely to make a significant future contribution to the field of psychiatry. The College provides a stipend for the Laughlin Fellows to attend the Annual Meeting and participate in all educational functions, allowing them to interact with College Members, as well as their peers in other residency programs.

Laura B. Dunn, M.D., Chair of the Laughlin Fellowship Selection Committee said, "This is an amazing, accomplished, and diverse group of individuals who were selected from a very competitive pool of candidates. As always, we look forward to giving them a very warm College welcome at the Annual Meeting in February. We know that the Membership will enjoy getting to know these impressive future leaders of our field!"

The College has announced the selection of two psychiatry residents and two psychiatry fellows – Colleen Leitner, M.D., Callie McCool, M.D., Eric McDonald, M.D. and Badr Ratnakaran, M.B.B.S. – to serve as Fellows on its PRITE (Psychiatry Resident In-Training Examination®) Editorial Board.

Taken by nearly all psychiatry residents in the United States, PRITE and CHILD PRITE® serve as an educational resource for psychiatry residents and training programs. The exams allow individual residents to compare their knowledge base and clinical skills to their peers and offer residency training directors an insight into the performance of their residents, enabling them to make their programs more effective.

In order to include the views of psychiatry residents who sit for the exam, The College selects residents and fellows from programs throughout the United States and Canada to serve on the PRITE Editorial Board. In addition to being invited to the Annual Meeting of The College, the PRITE and CHILD PRITE Fellows are required

to attend two PRITE Editorial Board meetings during their Fellowship. PRITE and CHILD PRITE Fellows participate in the question writing process by developing an assigned number of questions and then editing and referencing exam items.
