**Child Psychiatry Resident In-Training Examination® (CHILD PRITE®)
2021 Order Form/Agreement**

The psychiatry fellowship training program named below agrees to participate in the 2021 CHILD PRITE under the following conditions:

- Order date:** This contract must be received at the address below by September 15, 2021.
- Costs:** The cost will be \$130.00 per examination purchased (i.e., not per examination scored) for any training program whose payment in full is received **NO LATER THAN** the payment due date of October 15, 2021. **The cost to any training program whose payment is received AFTER October 15, 2021, will be \$165.00 per examination purchased.**
- Participation:** All fellows in the program must participate.
- Examination dates:** The CHILD PRITE must be administered **BETWEEN DECEMBER 1 and DECEMBER 7, 2021.**
- Test conditions:** The examination will be administered under the standardized conditions prescribed (i.e., the examination will be timed, proctored, closed-book). An Instruction Manual will be posted on-line by September 2021 and a hard copy will be sent with the exams.
- Compliance with Americans with Disabilities Act:** The training director guarantees, on behalf of the fellowship training program, that the program will take all necessary measures to comply with the Americans with Disabilities Act. The College must be informed **NO LATER THAN OCTOBER 15, 2021**, of any disabled fellow whose needs cannot be met through the provision of auxiliary aids or other on-site accommodations, and who will require modifications to the examination.
- Use of examination:** The CHILD PRITE may be used as one factor, among many, for assessing the competency of a fellow.
- Distribution of results:** Training Director and Resident Reports, which include scores, will be emailed to training directors and coordinators in February 2022 for distribution to fellows at a time deemed appropriate by the training director.
- Booklet distribution:** **The training director will be held legally responsible for the collection and storage of examination booklets before and after the exam.** Test booklets should be given to fellows when Resident Reports are distributed.
- Confidentiality:** The training director guarantees, on behalf of the residency training program, that except to the extent test results are used as one factor for assessing fellow competency, individual results for each fellow will be kept confidential.
- Data Sharing:** There are times when The College receives requests for PRITE data to be used for educational research and publication purposes. If a request is granted, the data will be devoid of any personal or identifying information specific to the Programs or to residents.
