From the President

I remember my first College meeting as if it were yesterday (although in full disclosure, I'm at the point where I sometimes have difficulty remembering what took place yesterday!). It was held in New Orleans, and as a Laughlin Fellow, I was profoundly moved by the remarkable camaraderie, the exceptionally high quality of the presentations (all given by psychiatry "rock stars"), and the burning intensity of the spices in the local Cajun crawfish. Thirty-five years later, recalling each aspect of the experience brings tears to my eyes (especially the Cajun crawfish).

Our 2019 Annual Meeting will once again create indelible memories for our membership. The theme, "The Future of Psychiatry: Embracing the Challenges," reflects the unprecedented degree of volatility in our social systems, and will illuminate ways in which our profession can play a leadership role in addressing several of the most pressing societal epidemics. Our Program Chair, Manny Tancer, has recruited national leaders who will address the most pressing issues, including our nation's growing epidemic of violence; the future of health care delivery, with an emphasis on the emergence of integrated care; and physician wellness across the full continuum from medical student to senior clinician. There will be important updates in areas ranging from Alzheimer's Disease to HIV/AIDS, as well as courses focusing on the use of technology in psychiatric practice, the management of refractory mood and anxiety disorders, the impact of public policy on the opioid epidemic, challenges facing our research mission, and the

clinical implications of the evolving access to medical and recreational marijuana use across the country.

Several components of the program seek to address a challenge facing our organization: the "greying" of our membership, and our limited diversity. These issues were a major focus of the February Board of Regents meeting, and your Board took several actions designed to expand the size and the diversity of our new member pipeline:

- 1) The Board approved reducing the Annual Meeting registration fee by 50% for attendees who were Laughlin or PRITE Fellows during the preceding five years.
- 2) A new Task Force will explore ways to expand the pipeline of young members.
- 3) The Board will ask the Membership Committee to take a fresh look at the application process to insure that we are treating all career paths equally in evaluating new member nominations.

From the Executive Director

The fashion industry is famously always one season ahead—and so the autumn collections are showing up in stores even as summer has barely begun.

Here at The College we like to plan Annual Meetings five years ahead. We just booked the 2022 Annual Meeting in Naples, and over Memorial Day Weekend I scouted out two properties in Tucson for the 2023 Annual Meeting. Why five years in advance? Very few hotels are booked that far out, so we have our pick of properties.

You might also wonder how we pick locations for the Annual Meeting. We try to alternate between East Coast and Western destinations to accommodate Members from different regions of the country. With a few limited exceptions (e.g., San Francisco) we also try to pick warm climates for the meetings.

We're also selective about meeting venues. The hotels have to be large enough to accommodate our room block (about 350-400 guest rooms on peak nights). They also need to have sufficient meeting space to house our plenary session and breakouts. Finally, we try to be sensitive to cost. We know it's expensive for Members to attend the Annual Meeting, so we tend to shy away from hotels that are too pricey. There are also intangible factors involved in selecting a meeting hotel: Does it feel like a College property?

If you look at the list of past meetings, you'll see certain patterns emerge. Arizona and California pop up repeatedly. With a limited number of options on the East Coast, we tend to favor Florida locations. Finally, we tend to go back to Hawaii about every five years.

Which leads me to next year's Annual Meeting in Honolulu. The meeting will take place in one of the most iconic locations on Oahu—the Hilton Hawaiian Village. Although it's a larger property than we usually book, we've limited our guest rooms to two towers to make the meeting more intimate: the Tapa and Rainbow Towers. The hotel has always attracted its fair share of star power—Elvis Presley filmed “Blue Hawaii” there in 1961. And those of you who are Gen Xers may remember the Brady Bunch visiting the Hilton Hawaiian Village in the 1970s. It's no wonder the hotel is popular in Hollywood: It features a 5,000-square-foot pool with the longest water slide in Waikiki. It is also directly adjacent to Duke Kahanamoku Beach and Lagoon, recently named the number one beach in America. Whatever you choose to do, you'll be able to find your own personal paradise.

Registration for the 2019 Annual Meeting will open in the autumn when we mail out the fall newsletter. Until then, have a happy, healthy summer.

The American College Of Psychiatrists Selects New Board Members, Officers

The American College of Psychiatrists elected new Members to its Board of Regents and selected Board Officers at its Annual Meeting in Tampa, Florida, on February 24, 2018. Members of the Board of Regents provide strategic leadership and oversight for the programs and future direction of The College.



Robert N. Golden, M.D.: Robert N. Golden was named President of The College. Dr. Golden is Dean of the School of Medicine and Public Health, Vice Chancellor for Medical Affairs, and the Robert Turell Professor of Medical Leadership at the University of Wisconsin-Madison.

He is a Director of the American Board of Psychiatry and Neurology and serves on the Board of Directors of the Association of Academic Health Centers. Dr. Golden received his bachelor's degree *cum laude* with honors in psychology from Yale University, and his medical degree from Boston University School of Medicine. Dr. Golden completed an internship, residency, and chief residency in psychiatry at the University of North Carolina and a psychopharmacology research fellowship at the National Institute of Mental Health.



Steven S. Sharfstein, M.D.: Steven S. Sharfstein was selected as President-Elect of The College. Dr. Sharfstein recently retired as President and Chief Executive Officer of Sheppard Pratt Health System where he served for 30 years. He is currently Clinical Professor of

Psychiatry at the University of Maryland. Dr. Sharfstein spent 13 years in leadership roles at the National Institute of Mental Health and at APA where he served as President. He attended Dartmouth College and earned his medical degree at Albert Einstein College of Medicine. He completed his residency in psychiatry at the Massachusetts Mental Health Center in Boston, and subsequently received an M.P.A. from the John F. Kennedy School of Government at Harvard.



Laura Roberts, M.D., M.A.: Laura Roberts assumed the role of First Vice President of The College. Dr. Roberts serves as Chairman and the Katharine Dexter McCormick and Stanley McCormick Memorial Professor in the Department of Psychiatry and Behavioral Sciences at the Stanford

University School of Medicine. She serves as the Editor-in-Chief for American Psychiatric Association Publishing, Books Division. She also has been the Editor-in-Chief for the journal *Academic Psychiatry* since 2002. Having received her bachelor of arts in history and master of arts in the conceptual foundations of science from the University of Chicago, she then completed her medical degree and a fellowship in clinical medical ethics at the University of Chicago Pritzker School of Medicine. Dr. Roberts received her residency training in psychiatry at University of New Mexico School of Medicine, where she then joined the faculty and established the University of New Mexico Institute for Ethics. Prior to her move to Stanford, she served as the Chairman of Psychiatry and Behavioral Medicine at the Medical College of Wisconsin.



Larry R. Faulkner, M.D.: Larry R. Faulkner was elected Second Vice President of The College. Dr. Faulkner is President and CEO of the American Board of Psychiatry and Neurology. From 1994 to 2006, Dr. Faulkner served as Vice President for Medical Affairs and

Dean of the School of Medicine at the University of South Carolina. Among other awards, Dr. Faulkner has received the Distinguished Service in Psychiatry Award from The American College of Psychiatrists, the Seymour Pollack Award for Distinguished Contributions to the Teaching and Education Functions of Forensic Psychiatry, and a Special Presidential Commendation for the Promotion of Psychiatric Education and Lifelong Learning from the

American Psychiatric Association. Dr. Faulkner received his undergraduate education at Whitman College and attended the University of Washington School of Medicine. He completed his residency at the University of Arkansas and a fellowship at National Institute of Mental Health.



Steven I. Altchuler, M.D., Ph.D.:

Steven I. Altchuler has joined The College Board of Regents. Dr. Altchuler is on staff at the Mayo Clinic in Rochester, Minnesota, where he has held a number of posts, including Medical Director of the Mayo Psychiatry and Psychology Treatment Center. He currently

oversees accreditation activities (Joint Commission and CMS) for all of Mayo Clinic's facilities in five states. Following graduate school at M.I.T., he worked at the NASA/Johnson Space Center doing research on changes in metabolism during space flight. He left NASA to pursue medical training at the Baylor College of Medicine, and subsequently completed residency training at the Mayo Graduate School of Medicine. He maintains his interest in space, and his practice consists of consultation psychiatry, aerospace medicine, and sleep medicine.



Darrell G. Kirch, M.D.: Darrell G. Kirch has joined The College Board of Regents. Dr. Kirch is President and CEO of the Association of American Medical Colleges (AAMC), which represents the nation's medical schools, teaching hospitals, and academic medical societies. Prior to

becoming AAMC President, Dr. Kirch served as the Dean and Academic Health System Leader of two institutions, the Medical College of Georgia and the Penn State Milton S. Hershey Medical Center. A psychiatrist and clinical neuroscientist by training, Dr. Kirch began his career at the National Institute of Mental Health, becoming the Acting Scientific Director in 1993 and receiving the Outstanding Service Medal of the United States Public Health Service. A native of Denver, he earned his undergraduate and medical degrees from the University of Colorado.

Eligible for Emeritus Status?

If you are over 70 or fully retired, you are eligible for Emeritus status in The College. As an Emeritus Member or Emeritus Fellow, you are no longer obligated to attend one of every three Annual Meetings or pay Active Member dues of \$420 (although we do suggest making a voluntary dues contribution of \$75).

Although Emeritus Members and Fellows may vote on all matters coming before the membership and serve on committees, they are not eligible to hold elective office or serve as a committee chairperson.

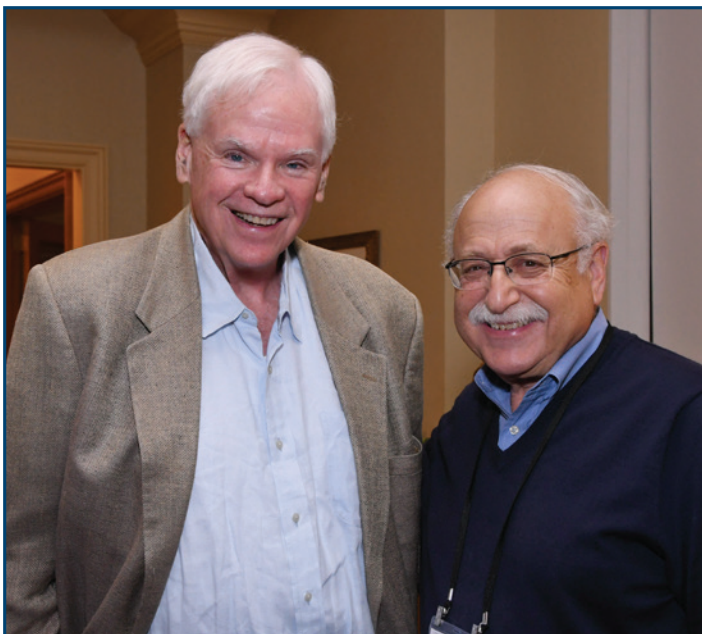
